# NOTICE OF RACE

### 1. Venue

The Zwin Race will be held the 21 July 2015.

The Zwin Race will be sailed in front of the coast of Knokke-Heist and Cadzand (Netherlands).

### 2. Organising Authority

The Organising authorities are the Royal Belgian Sailing Club (RBSC).

### 3. Governing Rules

The Zwin Race will be governed by:

The rules as defined in the Racing Rules of Sailing 2013-2016 (RRS) and any amendments.

The prescriptions of the KBYV/FRBY. A boat, while racing, may display a national ensign or club burgee, this change the prescription of the KBYV/FRBY 77.

The rules as defined in the Equipment Rules of Sailing 2013-2016 (ERS) and any amendments.

The Class Rules.

The Notice of Race.

The Sailing Instructions.

In case of conflict between languages the English text will prevail.

### 4. Classes

Open to **all Kiteraceboards en windsurfaceboards, dinghies and all Multihull Classes C1, C3 and C4**. The multihull groups are mentioned in the ISAF "SCHRS Rating System". **Two separated start for C1 and C3,C4 are foreseen**. Dinghies, kiteraceboards en windsurfaceboards at discretion of the race committee.

### 5. Advertising

This Event is designed as a Category "C" event in accordance with RRS Appendix 1 - ISAF Advertising Code, Regulation 20. The forward 25% part of the hull on each side of all participating boats shall only display advertising chosen (and required to be displayed) by that event organizer.

### 6. Eligibility

All entrants, to be eligible for the Zwin Race, shall: Comply with RRS Appendix 2 – ISAF Eligibility Code. Have a current Public Liability and Third Party Property Insurance policy, including coverage when racing at the venue of the Challenge, of not less than 1.500.000 € or equivalent for each boat. Any competitor under the age of 18 yrs will be required to obtain parental/guardian consent prior to commencement of the event.

### 7. Sailing Instructions

The Sailing Instructions will be given at the registration.

### 8. Scoring

The RRS Appendix A - Low Point Scoring system will be used.

**Five results are foreseen, multihull group C1, C3-C4, dinghies and Kiteraceboards en windsurfaceboards**. Multihull groups are mentioned in the ISAF "SCHRS Rating System".

### 9. Penalty system and Protest requirement

The alternative penalty rules RRS 44.1 and 44.2 are changed so that the 720° turn shall be replaced by a 360° turn and shall include one tack and one gybe.

## 10. Safety regulations

RRS 40 applies at all times while afloat, although flag "Y" will not be displayed. This changes RRS 40.

## 11. Racing Areas & Regatta Site

The Racing Area is the North Sea between Zeebrugge, Knokke Het Zoute and Cadzand (Netherlands). The Regatta Site is the **RBSC Duinbergen - Zeedijk 430A - B.8300 Knokke-Heist**.

## 12. Courses and Competition format

Two long distance races are scheduled, Knokke – Het Zwin and Het Zwin Knokke. In case of no long distance a maximum of 4 races can be sailed in front of Knokke-Heist.
